The IBU **Sustainability Strategy 2020-2030**, approved in September 2020, sets out the targets for 2030 across our five focus areas.


As defined by <u>Target 26</u>, our strategic plan, the overall vision of the IBU's sustainability efforts is to become a leader in sustainability in sport.

Achieving real and lasting change is only possible through the collective efforts of everyone in biathlon from the IBU as an organisation (Level 1), to our event series (Level 2) and the global biathlon family (Level 3).



# BIATHLON CLIMATE CHALLENGE PLANTS 100'000 TREES



Biathlon depends on cold winters and snow and as the IBU, we must accept our responsibility and reduce the sport's impact on climate. By sponsoring the Biathlon Climate Challenge, we advocated for climate action and sustainable development within the biathlon family. The Challenge was a fun way to connect our fans with the athletes and encourage them to keep physically active, with the added benefit of doing good for the environment.

April-May 2021 - Launched on Earth Day 2021, the Biathlon Climate Challenge reached its goal of 100,000 trees to be planted after 25 days. Almost 8,000 fans joined one of ten different teams - all led by biathlon stars - and collected 100,000 trees as they turned their physical activity into an opportunity to give back to the environment.

The fans and athletes' activity was tracked in the fitness app called Active Giving which converted the distance they had covered or calories they had burned into mangrove trees. The trees were planted in Madagascar by charity partner Eden Reforestation Projects.

## **IBU REWARDED BY IOC DOW AWARD**

Dec 2020 - IBU received the IOC DOW 2020 Carbon Action Award, aimed at recognising and accelerating effective climate action in sport. The awarded Olympic organisations, IFs and NOCs, measure their carbon footprints and are implementing diverse actions to reduce their carbon emissions based on structured carbon management plans. The IOC and Dow collaborated on this joint initiative to reward carbon offsets to those IFs and NOCs that have reduced their greenhouse gas emissions within the scope of their organisations and respective events. Thanks to the Award, the IBU's reported emissions were offset by Dow.

## **IBU SNOW NETWORK KICKS OFF**

May 2021 - The IBU Snow Network was launched in May 2021 with a webinar and the first IBU survey collecting data from IBU events on snow production, storage, grooming and transport, treatment and overall sustainability of snow management. Focused on the snow experts from all IBU's Organising Committees, the members of the Snow Network then met in Bolzano, Italy, to exchange ideas on the future of sustainable snow management. A total of 50 participants, representing 19 Organising Committees, IBU staff, IBU technical experts and independent researching experts attended the forum for discussion, networking and knowledge transfer. The meeting was held at the premises of IBU Supplying Partner Gold - Techno Alpin, a global leader in snow making technology.







# **IBU LAUNCHES OC SUSTAINABILITY AWARD**


Sept 2021 - Launched in Bled, SLO, on the occasion of the IBU OC meeting in September 2021, the IBU Organising Committee "Award for Excellence in Sustainability" promotes the implementation of sustainable practices that are high-impact, highly replicable and aligned with the IBU's Sustainability Strategy 2020-2030. The first award will be presented at the OC meeting 2022 in Oberhof, GER.

# **HIGHLIGHTS 2020/2021**

## **IBU HOUSE**

Following the move to the new headquarters in May 2020, future measures will include full transition to renewable energy for heating and cooling of the IBU House and improvements in waste management and recycling.



# **HIGHLIGHTS 2020/2021 OFFICIALS TRAVEL**

Travel amounts for the largest part of the IBU's own organisational footprint. Each IBU department has committed to an annual reduction of 5% in travel emissions. A new travel policy was implemented. The IBU fleet currently includes 3 hybrid vehicles. The interim aim is to increase the share of fully electric and hybrid vehicles to 50% in 2022.

## **SUPPLY CHAIN**

From Spring 2021, the Biathlonworld Magazine has given way to various digital newsletters, saving 1028 kg of printed matter. Future areas of focus include reducing emissions from shipping and the IBU's own events.



# **HIGHLIGHTS 2020/2021**

## **IBU EVENT SERIES**

All events in the 2020/2021 season took place without spectators. Thanks to good cooperation with several organising committees, initial calculation of the events' CO2 emissions was performed, to begin the collection of adequate data and establish the required processes.




We are reporting our emissions according to the Green House Gas (GHG) Protocol and apply their emission categories:

**Scope 1:** GHG emissions made directly, e.g. running boilers and owned vehicles.

**Scope 2:** GHG emissions made indirectly, e.g. buying electricity or energy for heating and cooling.

**Scope 3:** GHG emissions for which we are indirectly responsible for, e.g. purchased travel services or other products from our supply chain.

The IBU implemented various measures, such as a new travel policy, however the reduction in travel emissions is due to the impact of COVID-19 that restricted travel and prevented events from taking place, not these reduction measures.

The emissions following the move from the IBU Office 2021 reflect a full year in the new headquarters in Anif following move in May 2020. IBU Material Support was newly included in the 2021 calculation.

All IBU events during season 2020/2021 were held without spectators and followed a special COVID-19 safety plan. For the first time, the Level 2 of the IBU Events carbon footprint calculation was conducted using the specially developed IBU event footprint measurement tool and covered all the IBU World Cup and World Championships events during the 2020/2021 season. Due to COVID-19, events in the lower-level series (IBU Cup and IBU Junior Cup) had a severely curtailed season and were excluded from the measurement obligation.

# **SUSTAINABILITY BECOMES KEY CRITERION FOR WCH SELECTION**

Nov 2020 - For the first time, the candidates bidding to host the IBU World Championships 2024 and 2025 were required to outline their sustainability philosophy and plans for reducing the climate impact as part of their event concepts. Awarded in November 2020, Nove Mesto na Morave will host the 2024 event, and Lenzerheide (SUI) the 2025 edition.

# **ALL IBU EVENTS TO MEASURE CO2 EMISSIONS**

June 2021 - Starting from the 2021/2022 season, all IBU Events are mandated to measure and manage their carbon footprint. As part of its Sustainability Strategy 2020-2030, the IBU has committed to reducing its carbon footprint by 50% (4.5% per year). This commitment encompasses all IBU events. Using a specially developed IBU tool, the events will gain a solid understanding of the areas of impact by their event and help identify where to get started with their reduction efforts. Over time, the tool will also help quantify their progress in reducing and managing the event's impact on the environment and climate.

## **SUSTAINABLE EVENTS CHECKLIST** TO KICKSTART THE PROCESS

Sept 2021 - With the launch of the IBU OC Award for sustainability, the Organisers were provided a first piece of the toolkit to help them begin the transition toward a more sustainable event. The IBU Sustainable Events Checklist was designed to provide various options for key operational areas in an organising committee to consider, from lowhanging fruit to more impactful measures depending how far along the events are and their capacity to act given the more pressing challenges posed by the global pandemic.



# HIGHLIGHTS 2020/2021 BANNED C8 FLUORINE WAXES

June 2021 - The IBU banned products containing C8 fluorocarbons/ PFOA at all IBU events, in line with EU and EC regulations from the 2021/2022 season onwards. For the time being, low chain fluor C6 products are still allowed. The ban required written pledges by the NFs and their service partners and was controlled by spot checks on site. Given the health and environmental concerns connected to fluorine waxes, the IBU remains committed to a full fluor ban and to developing testing methods to ensure fluor-free competitions in the future.






# HIGHLIGHTS 2020/2021 FIRST SUSTAINABLE SNOW MANAGEMENT SURVEY

June-July 2021 - All the IBU Organizing Committees were invited to participate in an inaugural survey to set the baseline for current snow management practices. The survey dwelled into the details of snow production, storage, transportation, management, grooming and handling including salting in different conditions, altitudes and latitudes. A key focus of the initial survey was on understanding the energy and resource efficiency of the process. The initial findings were shared and discussed with the OC Snow Experts in the Autumn; the survey will be repeated in Spring 2022.

# HIGHLIGHTS 2020/2021 EVALUATING ALTERNATIVES TO THE USE OF LEAD IN BULLETS

Mar-Sep 2021 - The IBU engaged in a dialogue with the European Chemical Agency (ECHA) about a potential EU lead ban in hunting, fishing and outdoor sport shooting which could affect biathlon as a sport that uses small-bore rifles. The IBU is committed to closely cooperating with the ECHA and the industry during the upcoming months to find solutions to prevent interaction of toxic lead residuals with nature and wildlife.



# HIGHLIGHTS 2020/2021 REGIONAL EVENTS CONCEPT

In Autumn 2020, the IBU Regional events concept was launched, aiming to support the National Federations to implement good quality international competitions for young athletes based on international cooperation. The programme strives to increase the activity and efficiency of national associations and clubs in promoting biathlon among children and the youth. Eight regional winter events were organised despite COVID-19 during the 2020/2021 ski season as well as seven regional summer events in 2021.

## **NEW AREAS IN DEVELOPMENT PROJECTS SUPPORT**

In Spring 2021, new project targets including Sustainability, Gender Equality and Athlete Recruitment were added to the IBU National Federation Development project support programme. In the first year, projects by seven National Federations were supported by the IBU in these fields.






## **HIGHLIGHTS 2020/2021 EDUCATIONAL ACTIVITIES**



To amplify the chances to make a difference within and through the Nordic snow sports industry, the IBU seeks cooperation opportunities with its industry stakeholders, from the supplying partners to sponsors and marketing & media partners. As an initial step the IBU has introduced a code of conduct for its supplying partners and is in the process of implementing a sustainability appendix in all future contracts, outlining areas for mutual efforts.

# **IBU AS ACTIVE MEMBER OF THE SPORTS** FOR CLIMATE ACTION FRAMEWORK

Ongoing - A signatory of the Sports for Climate (S4C) Action Framework since June 2020, the IBU serves as an active, contributing member in the internal S4C working groups. All members must commit to measuring, reducing, and reporting greenhouse gas emissions, in line with the Paris Agreement. Launched at COP 24 in Katowice (POL), the United Nations Framework Convention on Climate Change (UNFCCC)-run framework calls on sporting organisations to combat climate change through commitments and partnerships according to verified standards and use sports as a unifying tool to create solidarity among global citizens for climate action. The S4C now counts more than 270 members.

# WHAT'S NEXT?

In 2022, the IBU will continue the work to incorporate sustainability into all its activities and raise awareness of the importance of climate action among all stakeholders.

Still heavily impacted by the Covid-19 pandemic but partially with spectators, the 2021/2022 Olympic season will help establish the emission measurement and management processes at IBU events and define individual action plans for the IBU organising committees.

Excitingly, the IBU is working ever closer with its sponsors, marketing, and media partners to define and implement solutions that make the sport more energy-efficient and reduce its environmental impact. Sustainable mobility - travel to, from and within events - will be a key area of focus but also a tough nut to crack since truly sustainable alternatives are not yet viable or available everywhere.

Internally at the IBU, each department has a clear role in implementing the IBU Sustainable Strategy 2020-2030 and has several projects underway. Each department has also identified a Change Agent whose task it is to ensure that everyone is aware of their sustainability tasks, priorities, and commitments, such as reducing departmental travel emissions by a minimum of 5% annually.

The IBU is committed to inspiring the global biathlon family to work together to limit global warming in accordance with the Paris Agreement to no more than 1.5° Celsius by 2030.
